All persons are asked to wear suitable footwear, long trousers, at least a short sleeved shirt & gloves, to remove jewellery especially earrings, not to carry bum bags or any bags, back packs or cameras etc. and must switch mobile phones off and to inform the ride leader if they are carrying medication. 8. Riders cannot smoke on horseback or ride whilst under the influence of alcohol or drug. 9. We do not guarantee the pace of any ride & Ride Escorts WILL slow the pace of a ride if ground or weather conditions or the ability or behaviour or a rider or riders threaten the safety of the ride. 10. All Staff are competent to escort rides. 11. We retain the right to terminate a rider's contract at any time. 12. DATA PROTECTION ACT 1998: Statement: I understand that the information I have given will be held in accordance with the Data Protection Act 1998 but may also be made available to insurers and any other concerned parties in the event of any injury or accident. 13.
